## Privacy Statement

1. The association collects, processes and uses personal member data using EDP within the scope of the association's purpose. As part of the club's activities, the data is passed on to third parties, e.g. sports associations, the organizers of sports and competition events, insurance companies, the service provider for the central collection of contributions, the tax consultant, etc., insofar as this is necessary for sporting and organizational reasons. The data is also used for honors and birthdays, including for publication on the association's website.
2. As part of the purpose of the association, photos, videos, film and sound recordings can be made, especially at sporting events. These recordings can be published on the club website, in the club house and also in press media and electronic media. Participation and/or presence at the events also represents consent to such recordings and publications.
3. ## **Contribution statutes of the BSV 63 Chemie Weißensee e.V. Table tennis department**

- 1.) The amount of the membership fee will be set as follows with effect from January 1st, 2022:
  - a) for children and young people: EUR 10 per month = EUR 120 per year
  - b) for adults: EUR 15 per month = EUR 180 per year.
- 2.) The membership fee is due annually by March 1st at the latest. of the year to be paid
  - a) as a result of the preference of each individual member or their statutory

- 5.) If a member is more than 14 days late in paying the membership fee, the member will be reminded in writing to pay. Dunning costs of 5,00 € will be charged for this. The payment period is to be determined with at least two weeks. Is this running
