Privacy Statement

- The association collects, processes and uses personal member data using EDP within the scope of the association's purpose. As part of the club's activities, the data is passed on to third parties, e.g. sports associations, the organizers of sports and competition events, insurance companies, the service provider for the central collection of contributions, the tax consultant, etc., insofar as this is necessary for sporting and organizational reasons. The data is also used for honors and birthdays, including for publication on the association's website.
- 2. As part of the purpose of the association, photos, videos, film and sound recordings can be made, especially at sporting events. These recordings can be published on the club website, in the club house and also in press media and electronic media. Participation and/or presence at the events also represents consent to such recordings and publications.
- 3. Every member has a general right to information about their stored data and to correction, Deletion and blocking of his data, insofar as this data may not be stored and processed due to legal regulations to fulfill the purpose of the association without the consent of the person concerned. If a member objects to the use of photos for honorary purposes and birthdays, the objection must be communicated to the association's executive committee in good time before the event and before publication. An objection to the further use of the data can lead to the termination of the association membership.
